Sub:- TSIIC – LAC – EODB 2017 – Online System for according Road Cutting / Right of Way permission guidelines along with time lines in TSIIC IPs-issued-Reg.

The Government as part of compliance of EODB 2017 has issued instructions directing all the ULBs and UDAs including IALAs to implement the reforms. Accordingly, vide reference 4<sup>th</sup> & 5<sup>th</sup> cited Government Orders were issued on Process Flow of Road cutting / RoW permission & Time lines in connection with laying power supply lines for electricity connection. The same has been indicated in the TSIIC website as well for reference.

In this regard, an online system has been developed by Centre for Good Governance which allows the following:

- a. Online submission of Road Cutting Permission / Right of Way application
- b. Online submission of documents and verification without the need for a physical touch point
- c. Online payment of Road Cutting / Right of Way fees (through Payment Gateway)
- d. Allows the users to download the final signed approval certificate from the online portal

(A) Therefore, the following guidelines are issued:

- i) The online system will be operational and shall not accept any application and documents related to Road Cutting Permission / Right of Way in physical form. Applications and documents submitted online will only be accepted.
- ii) The applicant should submit the application form along with all the necessary documents stated in the checklist and pay the fees online itself for getting the approval.
- iii) Detailed Procedures, Checklist, Fees and Timelines shall be uploaded on the Department Portal "[www.ts-roadcutting.cgg.gov.in](http://www.ts-roadcutting.cgg.gov.in)" as described below.

iv) **Procedure for Road Cutting Permission / Right of Way:**

1. Visit Web site for Road cutting / ROW permission i.e. Online Portal “<https://ts-roadcutting.cgg.gov.in>”
2. First Time Applicants need to Register on the Website. Login ID and Password will be generated and sent to the Applicant’s mail-id / through sms on the registered mobile number. Registered Applicant shall then Log-in to proceed with the online application.
3. Applicant need to fill in the required details online and upload documents mentioned in the checklist. Submit the Application to proceed.
4. The Commissioner / EO of the concerned IALA verifies the online application. If road pertains to IALA then application will be cleared for inspection, else rejected. Applicant will be notified through SMS or can check online after signing in.
5. After inspection approval will be accorded by the IALA Commissioner and payment of fee by the applicant will be notified.
6. Applicant can track the status of their application online. Applicant will be notified for Payment of Fees as per the approval accorded by the concerned IALA Commissioner.
7. Applicant need to pay the Fee amount through Online Payment Gateway available on the Log-in Portal.
8. Fee Payment Acknowledgement will be generated.
9. Permission will be accorded. Applicant can download the permission Letter from the Website.

System sends SMS to respective applicant at each verification process and on the updated status. The applicant shall be informed about the actions recommended and start date will be after all the clarifications have been received.

**(B) Checklist for Online Application:**

- i) Covering Letter Requesting the Road Cutting / Right of Way Permission.
- ii) Route/Road Map with Clear Road Dimension Details, Planned Activities, Location/Address.

(C) **Road Cutting Fees**

SI.No.	Types of roads	Charges
1.	CC Roads	Rs.1844/Rmt
2.	ST Roads	Rs.2275/Rmt
3.	Foothpaths	Rs.799/Rmt
4.	Berm/WBM	Rs.285/Rmt

The above fees are exclusive of GST .GST @ 18 % on Road cutting charges will be added extra on the amount of Road cutting charges.

The amount received towards Road Cutting charges/Right of Way permission fee shall be credited to the respective IALA account through online.

(D) **Timelines:**


- i) Online Application Submission by the Applicant
- ii) Application Scrutiny, Physical Verification by the Concerned I A L A Commissioner/ Executive Officer and Final Approval Within 6 days after receiving the Application
- iii) Payment of Fees by Applicant after Clearance
- iv) Final Permission Letter Issued - **Within 1 day** after payment of Fees

Final Permission Letter will be issued **within 07 Days** of the application provided all application documents are in order and no delay in fee payment.

Therefore, all the Officers concerned are advised to take necessary action accordingly and inform the respective Service Societies/Advisory Committees duly placing the same in the MC Committee meeting.

From the DIPP,GoI,Business Reform Action Plan 2017.

&&&&

In the reference read above, the Department of Industrial Policy and Promotion ("DIPP"), the Government of India has communicated certain reforms for improving the "Ease of Doing Business". Government of Telangana attaches utmost importance to improve "Ease of Doing Business" in the State. Laying down a transparent procedure for issue of 'Right of Way (RoW)' is one of the reforms being advocated.

2. Whenever issue of electricity connection to Industry / Business involves "Right of Way (including Road Cutting)" permission, a standard & uniform procedure is expected to be followed so as to deliver the service within a stipulated period. In this regard procedure given below is directed to be adopted by all concerned.

3. These instructions are applicable to following departments that maintain public roads / vacant Government lands where RoW (including Road Cutting) permission may be required for extending electricity connection:

- a. Roads and Buildings (R&B)
- b. Panchayat Raj (PR)
- c. MA&UD
  - i. Urban Local Bodies (ULBs - All Municipalities & Municipal Corporations including GHMC)
  - ii. Urban Development Authorities (UDAs - HMDA, KUDA, YTDA etc)
- d. I&C (TSIIC)
- e. Tribal Welfare
- f. District Collectors (O/o CCLA)

2. Procedure for RoW&Single Payment by the applicant are as follows:-

- a. DISCOMs shall identify the need for RoW permission during the process of estimation and the department concerned shall be intimated online for estimation of RoW/ Road cutting charges.
- b. The department concerned will intimate the RoW / Road Cutting charges online and DISCOMs will issue demand note (Estimation and RoW / Road Cutting) charges to applicant.
- c. RoW / Road Cutting charges shall be paid fully by the applicant along with work estimation charges.
- d. Within 7 working days of receiving payment, the RoW/ Road Cutting permission should be granted by the concerned department.
- e. If RoW is rejected on valid grounds, no further action would be required.
- f. If RoW (including Road Cutting) permission is not granted within 7 working days, approval is deemed to have been given.

3. Online System Development & Administration are as follows:-

- a. TSSPDCL, TSNPDCL and CESS shall be the nodal organizations to manage RoW (including Road Cutting) permissions for electricity

of their electricity connection module with logins to RoW sanctioning departments.

b. TSSPDCL, TSNPDCL and CESS to complete development of online application on / before 31.07.2017.

4. Accordingly, all the concerned departments shall take further necessary action in the matter.
