
That certain claims have been made by the third parties on the lands put for e-Auction of Ameenpur Village & Mandal, Sangareddy District and filed representation before the District Collector, Sanga Reddy. The District Collector, Sangareddy after verification of claims has suggested certain changes in the Layout. Accordingly, the Layout is revised.

Further, certain claims have been made by the third parties on the Ameenpur lands put for e-Auction by approaching the Hon'ble High Court of Hyderabad. As such, the Hon'ble High Court pleased to permit to go ahead with e-Auction subject to outcome of the final order.

In view of the above, the Final layout in respect of the Government lands in Sy. No. 343 to an extent of Acs.46.61 cts of Ameenpur (Vg.) & (M) of Sangareddy District along with Annexure-II (Statement showing the details of Govt. Land parcels/open plots at Ameenpur (Vg.) & (M) of Sangareddy District proposed for sale through e-Auction by TSIIC) is placed in the website of TSIIC ([www.tsiic.telangana.gov.in](http://www.tsiic.telangana.gov.in)). The above changes may be noticed.
