All Zonal Managers are aware that Micro Small and Medium Enterprises Development Act 2006 prescribes for filing of Entrepreneur Memorandum (EM-I) and Entrepreneur Memorandum (EM-II) for all enterprises. After the gazette notification dated 18/09/2015 for online filing of Udyog Aadhaar Memorandum (UAM), has replaced the filing of EM Part-I/II with GM-DIC. UAM (Annexure –I & II) shall be treated at par with EM-I/II wherever filing of EM was a prerequisite, eligibility, milestone or success indicator w.e.f 18/09/2015.

As per the gazette notification, the filing of UAM can be done on http://udyogaadhaar.gov.in. Every MSME unit should file its UAM through online and do not require any attestation or certification by any department.
