The guidelines related to reservation of plots in the Industrial Parks / SEZs of the Corporation for exclusive allotment to SC and ST entrepreneurs were issued in the circular  $\mathbf{1}^{\text{st}}$  cited.

In 2014, the Government of Telangana has brought out a new Industrial Policy giving special emphasis on the welfare and development of weaker sections. The Government has formulated various schemes for MSEs and weaker sections approving various fiscal benefits and infrastructure support. As per the T-IDEA (Telangana State Industrial Development and Entrepreneur Advancement) Scheme, the Government committed to reserve 30-40% of the land for MSMEs and weaker sections in the upcoming industrial estates to be developed by TSIIC and accordingly issued directions to TSIIC in G.O.Ms.No.28 of I&C (IP & INF) Department dated 29/11/2014.

The revised reservation policy has been placed before the Board. The Board has approved to adopt reservation policy as follows on a random basis (i.e., scattered over the entire Industrial area / SEZ).

- Reservation of 15.44 % of number of plots to Scheduled Caste Entrepreneurs,
- 2. Reservation of 9.34% of number of plots to Scheduled Tribe Entrepreneurs and
- 3. Reservation of 10% of number of plots to Women Entrepreneurs in the new Industrial Parks of TSIIC.

All Zonal Managers are therefore requested to follow revised guidelines with regard to reservation of plots in the new Industrial Parks / SEZs as well as existing Industrial Parks /SEZs for exclusive allotment to SC / ST / Women Entrepreneur on priority basis with immediate effect.
