The Scheme of granting extension of time to the Industrial units for implementation of the project / codonation of delay in implementing projects is closed on 30/06/2017 and there is no further extension of Scheme.

The proposals submitted by respective Zonal Managers were examined in detail by the EoT Committee and disposed off, on merits of each case. The Zonal Managers should monitor the progress made by units in implementation of project periodically where the EoT is granted and shall furnish status reports on stage of implementation of the projects duly verifying the timelines with ground position given by the allottees as per the guidelines issued in the circular 2<sup>nd</sup> cited. In case of failure to adhere to the time-lines given by the allottees, action should be initiated to withdraw EoT orders and for cancellation/resumption of premises immediately.

The Zonal Managers shall also initiate immediate action for cancellation of allotment and resumption of the land against the non-implemented cases who have not come forward for availing EoT Scheme or whose EoT applications stands rejected by the Head office, as per the due procedure prescribed.

In cases where the NoC is given to the financial institutions or the Sale Deed is issued before/during implementation of projects at the request of APSFC/Financial institutions for sanction of term loan for implementation of project and where the projects are remaining unimplemented or partially implemented within the stipulated period as per the terms & conditions of Sale agreement or within the extended period of time as per the terms & conditions of EoT and including the cases where the loan is not disbursed to the allottee after executing and registering Sale deeds due to non-compliance of terms & conditions of their Sanction order, Zonal Managers are requested to verify all such cases within a month from date of receipt of this circular and shall take immediate necessary action following the due procedure in consultation with financial institutions including obtaining orders of the Courts and shall submit compliance reports periodically to the Head office till action is completed against all units listed under this category.
