In pursuance of the announcements of the Hon'ble Prime Minister of India, Ministry of Home Affairs (MHA) for lockdown of the country in view of the severity of the contamination of COVID-19 virus, Government of Telangana has issued G.O.Ms.No.45 on 22/03/2020 for total lockdown of the State with effect from 23/03/2020 to 14/04/2020. Telangana Government issued another order on 19/04/2020 extending lockdown up to May 07, 2020.

Further, considering the unprecedented circumstances due to COVID-19 virus and the economic hardships faced by general public, the Central Government brought Covid-19 under Force Majeure Order.No.F.18/4/2020-PPD dated 19/02/2020 and announced certain relaxations in respect of payments due to Government Departments, Corporations, Government Companies, Cooperative Institutions, Boards, Authorities through DOR.No.BP.BC.62/21.04.048/2019-20 dated 17/04/2020 of RBI. According to clause No.(ii) of the said order, banks and other financial institutions would give an option to borrowers of term loans for deferring payment of instalments falling due between March 1st and May 31, 2020.

In compliance of the aforesaid instructions of Central and State Government, the Corporation has decided the following:

- 1. All the payments towards cost of the plot that fall due on or after 22/03/2020 have been deferred till 31/05/2020.
- 2. No penal interest on any other dues for the period 22/03/2020 to 31/05/2020 shall be charged. However, regular interest @ 16% p.a. which is to be paid in normal course of times will be charged.
- 3. However, allottees who are willing to pay the cost within due date may be encouraged to make the payment.
- 4. No coercive action will be taken to recover any dues during this period.
