I am to invite your attention to the reference cited and inform you that the Government of Telangana is working towards making the vision of Digital Telangana a reality by providing 4G services in major cities, enabling Wi-Fi facilities at numerous public locations, expanding Mee-Seva services, and working towards the goal of establishing Digital Telangana Centres at each Gram Panchayat.

2. In this regard, I am also to inform that continuing along the path to maximize the creation of a digital knowledge economy, the ITE&C Department has launched the Hyderabad City Wi-Fi Program or Hy-Fi, the largest city-wide Wi-Fi program nationally. Under Hy-Fi, a total of over 3000 public category locations, comprising of tourist spots, hospitals, government buildings, bus stations, police stations, parks and gardens, road stretches, etc., are being covered. Interested Wi-Fi service providers, which include Airtel, BSNL, Quadgen, ACT Fibre Net, RJIL and others are participating in this program.

3. I am therefore request you to provide necessary implementation support to the ISPs, the ITE&C Department, Government of Telangana has issued an enabling GO MS No. 1, dated: 02-03-2017 (Copy Enclosed). Further, it is to bring to your notice that the incentives and support mentioned in the enabling GO shall also be applicable for areas under the purview of TSIIC. Extend necessary implementation support and benefits, as mentioned in the GO, to the participating ISPs providing public Wi-Fi at locations maintained by TSIIC.

**ORDER:**

The Government of Telangana has identified the implementation of free Wi-Fi services as a key reform priority in the field of Information Communication Technology (ICT) across the State and as an initiative a pilot project was already launched at Necklace Road around Hussain Sagar.

2. The prime objectives and goals of the Government are
  - a) To provide Free Wi-Fi services to all the citizens, tourists and visitors.
  - b) To make Wi-Fi (free internet access) network available to all the citizens, and mobile network facilitating faster and convenient information searches, and social use of internet to keep pace with today's knowledge societies.
  - c) To bridge the Digital divide.
3. The Government of Telangana aims to meet its objective of becoming one of the key instruments for promoting the social use of new information and knowledge technologies.
4. **There are manifold benefits of offering free Wi-Fi services, including:**
  - a) Enriching Community life and enhancing public safety.
  - b) Provision of marketing, communication portals to public spaces adding to their vibrancy.
  - c) Providing valuable digital resource enabling out of office workers & travellers to use internet on their mobiles in public spaces.
  - d) Enhancing educational initiatives by providing better connectivity to public institutions & universities.
5. The present focus on implementation of free Wi-Fi services in **Hyderabad Metro Area** is mainly to provide residents with the biggest free public Wi-Fi network. This can be possible only 'through the use of Municipal centres and public spaces as Wi-Fi zones'. Wi-Fi Hotspots constitute one of the biggest free open access networks in the whole of Hyderabad.

The Government's goals include encouraging and boosting the number of users connected to the network and becoming an instrument which places internet access within the reach of residents of the Hyderabad city and its neighbourhood from a wide range of municipal centres and through any IT device.

6. The Government of Telangana hereby issues the following orders enabling the intended Service Providers for easier and smoother installation and maintenance of Wi-Fi Hotspots.
- a) The service providers shall be liable to pay the charges for underground (ROW and restoration) fibre cable laying at the following rates

S. No.	Type of Road	Charges
1	CC Roads	Rs.600 per mtr
2	BT Roads	Rs.600 per mtr
3	Footpath	Rs.300 per mtr
4	Berm/WB,	Free of cost

- b) Aerial cabling shall be permitted in a systematic manner without obstructing pedestrians or vehicular traffic in areas where underground cabling is not feasible. In locations where cable ducts are already available, which includes ORR, service providers have to necessarily use the available infrastructure.
- c) A rent of INR 500/- per month per pole, which is payable by the Service Provider(s), which includes Right of Way (ROW) on overhead fibre and permission to use the pole for other wireless backhaul equipment shall be applicable. In case of no equipment installation on a pole, the Service Provider(s) shall be charged INR 50/- per month per pole.
- d) Payment of electricity charges for access point basis to GHMC as fixed together by ITE&C Department, Energy Department and GHMC on mutually agreeable terms and conditions.
- e) Permissions to Service Providers may be accorded for free use of the site location to set up Wi-Fi Hotspots at the Government owned buildings like Courts, Hospitals & Educational institutions by the respective departments within Hyderabad city under a single window desk at GHMC for free access for all state owned buildings and establishment for installing and maintaining Wi-Fi equipment at different locations. The service providers should provide free access for Wi-Fi for the building owning department.
- f) Advertisement subsidy shall be provided in the form of free provision for installation of not more than two points of advertising in the radius of Wi-Fi hotspot operated by the Service Provider(s). The advertisement should be a co-branding model displaying logos of Government of Telangana, the site owner (i.e., GHMC, HMDA etc) and the service provider(s). These should only be in the form of message boards, and not advertisement hoardings.
