1. Andhra Pradesh Re-organisation Act 2014 for re-organisation of existing State of Andhra Pradesh received the President's assent on 01 March 2014. The 'Appointed Day' for the new State formation of "Telengana" is 02 June 2014. The Act requires the State of Andhra Pradesh to initiate activities related to creation of successor states including the apportionment of assets, liabilities, employees, contracts between the two successor states. Part VII of Andhra Pradesh Re-organisation Act 2014 deals with provisions relating to services which Sec 82 directly deals with Employees of Public Sector Undertakings.

2. In pursuance to the above, the two divisions namely Andhra and Telengana divisions are formed w.e.f 2.6.2014 as per the guidelines issued by The Government from time to time. The existing sanctioned posts are allocated based on population ratio in the Demerger Scheme which is nearer to the actual usage. Employees are allocated to the two divisions on provisional basis. The Demerger scheme was approved by the Board of Directors in their 199<sup>th</sup> and 202<sup>nd</sup> meeting held on 2.5.2014 and 26.3.2015 respectively. The Board of Directors in their 202<sup>nd</sup> Meeting held on 26.3.2015 discussed and authorised VC&MDs of Andhra Pradesh and Telengana divisions to finalize the modalities for the allocation of Employees as per the section 82 of the A P reorganisation Act.

3. The options for allocations of employees are called for vide reference 2<sup>nd</sup> cited expressing their preference for allocation to either of the States in option form prescribed by the Kamalnathan Committee for state Government employees and to submit in ink signed hard copy with supporting documents.

4. The controlling officers of both divisions have scrutinised the factual accuracy and certified the option forms and documents submitted by Employees and communicated verified employee data to the personnel department. Based on the verified data of employees, the personnel department reviewed the option forms and placed the data in order of Seniority available as on 1.6.2014

5. Managing Directors of both Divisions (Corporations) discussed the draft modalities for distribution of Employees between APIIC & TSIIC in the light of provisions of section 82 and guidelines of Kamalnathan Committee on allocation of State Government Employees. After discussions, the modalities for distribution of personnel between successor Corporations were approved on 15.6.2015. A copy of the modalities are displayed in website for ready reference.

6. Consequent to finalisation of modalities by Managing Directors of both divisions (Corporations), tentative allocation of the employees is finalized and approved by VC & MDs of both divisions(Corporations). Tentative allocation list is here with appended in the annexure-I,II, III and IV for communication to the employees and placing in the website. other

7. Any employee who feels aggrieved by the tentative allocation, would be at liberty to submit his/her representation within 14 days from the date of the memo to the Vice Chairman and Managing Director of the Corporation to the Successor state in which he/she is serving, with a copy to the Vice Chairman and Managing Director of the other Corporation.

8. Representation of an employee should be self-contained; clearly indicating the specific points of grievance and should be addressed to the VC & MD.

9. The successor Corporations shall furnish its official comments on the representations received by keeping in view the law, rules and orders and would forward the same for further consideration of the Committee consisting of the Vice Chairman and Managing Directors of the Successor Corporations.

10. The Committee will consider the representation of the employees after taking the views of both Corporations for taking a final view in the matter.
