New IALA guidelines were issued vide reference cited,

Some of the Commissioners/EOs, Chairmen of the Service Societies have informed that processing of certain IALA works including maintenance works are being delayed at Zonal Office level requesting to issue guidelines permitting certain works to be taken up at IALA level, like sweeping of roads, door to door collection of Garbage lifting, Street light maintenance and clearing of drains under the control of Commissioners/EOs, APIIC – IALA.

The representations and requests received are examined in detail and it is considered to issue the following guidelines in continuation of the guidelines already issued.

3	Minor Repairs to Roads, drains	<p>The Commissioners/EOs are permitted to take up emergency /petty works such as damage to drains, removal of silt in drains, repairs to pot holes on the roads on a particular stretch/minor removal of debris, vegetation removal etc.,</p> <p>To incur expenditure on the above works preparing peoples estimate involving the works committee of the society to be prepared and with due Administrative sanction by the Commissioner/EO, IALA. The expenditure for the works should not exceed Rs.20,000/- on any single requirement and should not exceed Rs.2,00,000/- p.a. these works however are to be taken up subject to availability of funds in IALAs. All the records of these works shall be audited annually by APIIC Internal Audit.</p>

For the Non Engg works like security personnel, sweeping of roads, Door to Door collection of garbage etc., the respective commissioners of IALAs are permitted to take up the works without technical sanction.

The above guidelines shall come in to force with effect from 01.04.2014 onwards.

The other remaining works such as repairs and maintenance of roads, construction of drains, construction of compound walls to open spaces, providing water supply, Avenue plantation, providing street lights etc., the Zonal Manager is competent to execute the works duly following the new guidelines issued on 10.10.2013.

**TERMS AND CONDITIONS**

Name of Work: Repairs and Maintenance to the existing street light fittings at Hardware Park and Master Plan road at Kancha Imarath, Maheswaram(M), RR Dist under IALA works for one year.

1. The bid is for a period of 12 (twelve) months from the date of entrustment of work.
2. The job undertaken should be composite nature of different tasks related to Repairs and Maintenance of Street lights which are briefly listed below:  
The APIIC-IALA has commissioned street lights in Hardware Park(layout area) and Master Plan road between M/s Indu Tech Zone and M/s Brahmani Tech Zone at Kancha Imarath, Maheswaram(M), RR Dist.

(a) Octogonal Poles(Single:102 and Double:81)	183 Nos
(b) 250W SV lamp fittings with lamp	264 Nos
(c) Feeder Pillar boxes	3 Nos
(d) Energy Meters	2 Nos
(e) High Masts (4X250W MH)	1 No

**3. Scope of Work:**

- i) Replacement of fused out lamps, chokes, ignitors and capacitors etc., including Maintenance of all street lights
  - ii) 90% glowing should be ensured at any given point of time.
  - iii) Cleaning of luminaries once in six months as prescribed by APIIC-IALA normally in the month of August and December. APIIC-IALA can insist on cleaning of luminaries other than those two occasions. If situations warrants the contractor shall do at no extra cost.
  - iv) Timely ON & OFF of street lights & maintenance of Micro Processor based Timers, MCCBs, MCBs and Feeder Pillar boxes.
  - v) Painting and numbering of the poles, repairs to the pedestals wherever necessary during maintenance of street lights.
  - vi) Self line clearance during maintenance of street lights
  - vii) Collecting Meter readings every month jointly with APCPDCL authority and furnish the same to the APIIC-IALA within time and cheques towards CC charges shall be collected from APIIC-IALA and paid to concerned departments. The receipt so obtained shall be submitted back to APIIC-IALA every month. In case of surcharges etc., if levied by APCPDCL due to delay in this process the same will be recovered from the contractor's bills.
4. Maintenance Contract period will be for 12 months from the date of agreement, the contract can be extended for further period on the same rates depending on the performance of the contractor and on mutual consent. The contractor has to take up the work on allotment AS IS WHERE BASIS.
  5. No variation in prices on any account is acceptable once the contract is accepted and the price shall be firm through-out the contract period and extensions thereof except statutory variations
  6. The contractor and the required Supervisory staff shall be available on a mobile phone number round the clock.
  7. Contractor should closely monitor the complaint register available in APIIC-IALA office or at contractors office on daily basis for the purpose of noticing the complaints received.
  8. Contractor shall prepare master register in prescribed proforma comprising of pole number, type of fitting, area etc.,(Copy of Master register should be submitted to APIIC-IALA).

9. Contractor will be held responsible for missing luminaries (Street light fittings, MCCBs, Timers, Contactors, FPBs), automatic switches on account of theft, vandalism etc.,
10. Contractor will be held responsible for the daily inspection of all areas and action there after for proper maintenance of street lights.
11. Contractor should use approved branded materials only (Viz. Philips/ Bajaj/ Crompton Greaves) for replacement. The contractor should maintain material stock required for 15 days in advance at any point of inspection by concerned officers. If excess CC charges are received due to sub standard material, the same will be recovered from the bill of contractor.
12. Contractor shall guarantee the quality, efficiency and performance standards of the Electrical materials used during the maintenance contract.
13. Contractor should remove accident/ bottom rusted/ bent street poles belonging to APIIC-IALA without any extra cost and removed street light poles to be handed over to APIIC-IALA.
14. Contractors shall arrange the mark the name APIIC-IALA with date on all types of lamp accessories and fittings changed during the maintenance period and the replaced spares should be handed over to APIIC-IALA.
15. Struck, burnt, faulty meters status should be brought to notice of the CPDCL authorities and get it replaced by CPDCL with new ones under intimation to APIIC-IALA
16. The contractor should intimate regarding power pilferages from the street lights and take every care to prevent the same.
17. No sub-contract is allowed
18. Contractor should adhere to IERC Acts and Rules and also CPDCL regulations while carrying out street light maintenance work.
19. Contractor should carry out the maintenance work in consultation with CPDCL authorities and APIIC-IALA authorities.
20. Contractor shall have a valid Electrical Supervisor permit issued by Chief Electrical Inspectorate, Government of AP.
21. Contractor shall follow the rules laid down by Electrical Inspectorate, the Commissioner for labour, the Govt. of AP will not be responsible for any dispute arising there on.
22. Contractor shall be held responsible for all consequences and financial obligation if any in the process for execution of the present contract. The contractor shall engage the skilled, semi skilled as per the norms prescribed by the Labour Department & APCPDCL.
23. Contractor shall engage only qualified personnel for maintenance of street lights failing which penalty will be imposed accordingly.
24. The APIIC, IALA will not be held responsible for any unforeseen accidents, mishap and accident in the course of maintenance during the period of contract staff employed by the contractor. Any failure to provide Insurance cover will result in immediate termination of contract.
25. Contractor should have suitable equipment/ ladder of sufficient height, vehicle and employ the skilled electricians having Electrical Wireman Certificate with valid permit issued by Chief Electrical Inspectorate, Govt. of AP.
26. There should not be any advertisement on the Electrical Pole, other than what is permitted by APIIC-IALA. The contract would be terminated, the security deposit will be forfeited and the contractor will be black listed in participation of any other ventures, if it is found that the Contractor is allowing Advertisements, Advertisement rights are completed reserved with APIIC-IALA.
27. Contractor is not permitted to display any board advertising his agency/ product or any other advertisement boards on street lighting poles.
28. Any breach of Terms and Conditions of contract during the period of contract will result in termination of contract and forfeiture of Security Deposit.
29. Cost of repairs/modifications necessary due to negligence of operator shall be recovered from the contractor as per assessment of APIIC-IALA. If the contractor fails

to repair within the period given to him, the same should be got repaired through other agency at his risk and cost.

### 30. PENALTY CLAUSE

Contractor should repair/replace the fused out light along with non- glowing points within 24 hours from the time of complaint is recorded. In case of failure, penalty will be imposed as below:

- a. Beyond 24 hrs, Rs 150/- (Rupees One hundred fifty only) per fitting per day and it is cumulated or compounded if it is not repaired.
- b. Contractor is responsible for switching ON & OFF the street lighting according to the climatic change in Microprocessor based Timer fitted in the system. At any point the gadget should not be meddled with and should maintain in good condition.
- c. In case of timer failure, if it is not repaired within 48 hrs, Rs 150 (Rupees One hundred fifty only) will be imposed for timer and non glowing penalty of fittings will also be charged in addition to the above.
- d. Day light glowing Rs 100/- (Rupees Hundred only)

31. For shift duties required to be performed as per duty chart but not performed by the operator of contractor for whatsoever reason a suitable penal recovery will be effected from the payments due to the contractor by APIIC-IALA.
32. The contractor is expected to employ reserve operators in performance of contract consequent to labour regulatory/status on working of personnel on National Holidays etc., and also on any day when operator(s) is/are absent from duty.
33. Duty charts of the personnel are to be displayed in the premises. The APIIC-IALA can inspect the attendance on the basis of duty chart.
34. The installations shall be manned and operated on all 7 days of the week irrespective of holiday and Sundays. Street lights should not be stopped except for the reasons mentioned below:
  - a. Power shut down by APTransco/APCPDCL
  - b. Any other reasons to be specified by APIIC-IALA
35. The operating personnel shall be qualified and experienced in the trade for which he employed. The contractor shall employ skilled workmen holding proper license under IE Act/Rules. The provision shall be compiled with even if the tenderer/contractor is a registered licensed contractor. The contractor shall be responsible for complying with the applicable provisions of IE Act/Rules.
36. The contractor shall produce certificates of qualifications and experience of operating personnel to the APIIC-IALA.
37. The operating personnel shall have thorough knowledge of safety precautions during emergency cases and also be conversant with the APCPDCL/APTransco rules/regulations, IE Act/rules and Indian factory Act/Rules.
38. The contractor should ensure that the whole premises of street lights area/poles to be kept neat and working condition.
39. The contractor has to keep all tools and tackles available to the operators for safe and satisfactory performance of their duties
40. The contractor has to issue necessary operating instructions to operators of different types of installations and ensure their compliance.
41. Regarding Street lights all spares such as bulbs, chokes, igniters, condensers, UG cable etc., if required shall be replaced by the contractor only at his cost. At no time not even Single Street light is found not functioning they should be rectified/replaced within 24 hours.
42. The contractors should guarantee that they will deploy a minimum number of operating personnel which are required for successful maintenance of the scheme.
43. The repairs and maintenance contract will commence from the date of taking over the system.
44. Any dispute arising out of this contract, the decision of APIIC-IALA, HWP is final.
45. No arbitration proceedings are maintainable regarding any dispute out of this contract.

46. Contractor should submit his bill in the first week of subsequent month to the Commissioner APIIC-IALA for arranging payment.
47. Penalties will be levied by the APIIC-IALA based on the quantum of default.
48. Contractor should maintain the Street light poles by removing the buntings, bird nests, threads, banners and take up pruning of tree branches around the fittings for obstructing illumination as and when required failing penalty will be imposed as the case may be at the rates as per penalty clause above.
49. During the course of Contract period, the statutory deductions of Income Tax etc., at the applicable rates will be deducted on gross payment of the Contractor's bills.
50. Any short fall in the performance as above will be made good by APIIC-IALA, duly taking up the work departmentally and amount equivalent to the double amount payable shall be recovered from the payments to be made to the agency.
51. Bidder shall comply with all labour laws in force.
52. The contractor should not engage child labour for carrying out of assigned work. Any violation/lapse in this regard entail cancellation of contract apart from taking action as deemed fit under different concerned laws.
53. In case of wrong and excess payment being made due to over sight, such amount will be adjusted/recovered from the subsequent bills. The decision of the appropriate authority is final and binding on the part of the contractor.
54. The contractor should have valid PF registration certificate issued by Regional Provident Fund commissioner.
55. The contractor should have electrical license in Grade A issued by licensing board of Govt. of AP.

#### **56. LABOUR & FAIR WAGES CLAUSE**

- a. The contractor shall employ labour in sufficient number to ensure prompt repairs within specified time and to satisfaction of APIIC-IALA.
- b. The contractor shall comply with the provisions of the payment of wages Act 1936, Minimum Wages Act 1948, Employers liability Act 1930, Workmen's Compensation Act 1923, Industrial Disputes Act 1947, Contract Labour Regulation and Abolition Act 1970 or any modifications thereof or any other law relating there-to and rules made there under from time to time.
- c. The contractor shall ensure strict compliance of the provisions of the "Employees Provident Fund Act 1952" and the scheme framed there under in, so far as they are applicable to their establishment and the agencies engaged by them, the contractor is further required to indemnify the Corporation against any loss of damage whatsoever that may be suffered by the Corporation as a result of any claims, damages or penalties for any failure or non-compliance on their part with the provisions of the aforesaid Act and the scheme framed there under.

The contractor will ensure implementation of all relevant provisions of the above act and shall be deemed to be the principal employer for the purpose. Accordingly they will get themselves registered with the concerned statutory authority as provided under the Act and shall be directly responsible to the authorities there under for compliance with the provisions thereof.

#### **57. Maintaining of Poles**

- a. Broken/Damaged Cement concrete footings and pedestals shall be repaired.
- b. Repairs to concrete pedestal of street light poles should be done before monsoon. If not it will be got done and deducted from the payment to be made.
- c. The contractor has to provide alternative arrangements for defective cable and see that all the lights should glow.

#### **58. Contractor's Risks/ Injuries due to Accidents**

All the risks of loss or damage to physical property and personal injury and death which arise during and in consequence of the performance is the responsibility of the contractor.

- a. The contractor shall at all times indemnify the APIIC Ltd against all claims which may be under the workmen compensation act or any statutory modification

thereof for the rules of compensation payable in consequence of any accident or any injury sustained by any workman and engaged in the performance of business relating to this contract.

- b. In all cases of personal injury to the workman employed by a contractor on this work for which contractor is liable to pay compensation under Workmen Compensation Act. He shall pay the prescribed medical fee to the medical officer for the issue of C&D forms as prescribed, failing which the said fee will be paid to the medical officer by the Corporation and recovered from the Contractor's bills.

**59. Indemnify Bond executed by the contractor while entering into agreement.**

- The labour engaged by the contractor shall be courteous, obedient and sincere to APIIC-IALA, Engineers while discharging the duties entrusted to them. In case of any misbehavior by any labour engaged, the contractor shall take full responsibility in replacing the concerned with a suitable trained person.
- Any notice to the contractor shall be deemed to be sufficient served if given or left in waiting at his usual place of business or legal address given by the Contractor.
