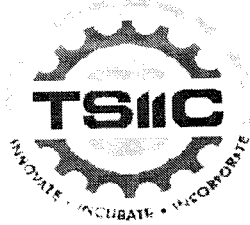
TSIIC Ltd under Local Authority status to promote the objective of “Self Governance” the concept of Notified Industrial Areas Service Society was introduced by involving the tax payers of industrial units located in the Industrial Parks duly registering the Service Societies under the relevant acts.

Vide Circular 1st cited & 2nd cited, instructions were issued communicating certain guidelines to the Service Societies regarding model bye laws, conduct of elections etc., to ensure the Services Societies function on democratic lines and thereby take better services of IALA.

Subsequently, revised guidelines were also issued vide reference 3rd cited. In spite of this, certain discrepancies are observed in the bye laws adopted by the Service Societies. Hence it is felt necessary to modify the Bye Laws and regulations in conducting the elections.

The matter has been examined in detail and placed in the 3rd Board meeting of APIIC/TSIIC meeting held on 27.03.2015 and the same was approved. Hence, the following amendment shall come into force with immediate effect.

for larger IALAs i.e having more than 1000 assesces

- a) Any member of the Service Society may hold a **given** post for a maximum of two terms of three years each and
- b) Hold **any post** for a maximum of four terms subject to a break of one term after two continuous terms.

Accordingly, all the Service Societies shall follow the above guidelines for better functioning of the Service Societies, duly amending their by-laws immediately.

A copy of this Circular may be placed before the ensuing meeting of the Managing Committee for information and necessary action in the matter.

All the Zonal Managers and Commissioners/Executive Officers of TSIIC-IALA are advised to follow the guidelines forthwith.
